 - A. Permits for coastal projects

B. Proposed developments and other building projects

The new Aldi supermarket and the bank near Exit 53 will be discussed at the 2-13-20 Inland Wetlands meeting. Drainage is a concern. Co-Chair D. Fitzgerald will attend the meeting and bring information to the next meeting.

- C. Invasive plant control
 - Co-Chair D. Fitzgerald spoke of the upcoming Earth day on 4-25-20 and some of the activities that are planned. He noted that the Public Works dept. is starting to clear invasive plants from the rear of the Early Learning Center and the area to Chet's pond in order to prepare the area for the Pollinator Pathway planting.
- D. Natural Resource Inventory (next publication 2023)

Copies were given to the teacher at Branford High School who requested them. The Commission discussed the need for a replacement for Noble Proctor (who worked on the previous Inventory). Co-Chair D. Fitzgerald thought that the Fall would be a good time to start the project. The Inventory is due by June 2023.

The Commission briefly talked about the need for new Commissioners to join the group and they offered some suggestions.

E. Branford Festival

Co-Chair D. Fitzgerald will meet with Lana who is working on a recycling display. He also said the Oceanology group will have a table or 2 at the Earth day event.

F. Animal Ordinance

Chairman Hannon said she thinks the next step is to meet with First Selectman Jamie Cosgrove to discuss the animal shelter expansion project and to update the ordinance regarding animal waste. And also to promote responsible pet ownership.

G. Pollinator Pathway

Co-Chair D. Fitzgerald said there is a subcommittee that meets the first Monday of the month that is made up of people from different groups throughout town. They meet and discuss various sites for the Pollinator Pathway project. Comm. Sweeney said there is a link for plants that would be suitable for the Pollinator Pathway.

Co- Chair D. Fitzgerald suggested a plant sharing day in the Spring. More details to follow.

H. Atlantic Wire Site

Comm. Hall reviewed the records and it looks as if the permits are in place but she stated she didn't have the qualifications to determine any risks. An attorney is needed to determine the risk and if so, it needs to be reviewed by DEEP.
