Owner pointed out what the extent of lawn was and where wooded area began. Commission reviewed 2016 aerial imagery of property and observed site and wetland areas. Mr. Genua, owner of 85 Flax Mill Rd, pointed out wet areas on his property. Commission inquired about what appears to be a drainage ditch on properties behind 113 Flax Mill; staff said they would bring a map of the area to the next meeting.

Commission arrived at site at 6:00 pm. The group walked the property. Surveyor pointed out staked location of rear building corners, area of proposed wetland impact, location of stormwater basins relative to test pits, and explained extent of paving relative other locations pointed out.

Commissioners Greenalch and Sette left a bit early (around 6:30); did not view the area where stormwater basin 4 is proposed or full westerly extent of proposed parking.
