02 MOTION (Prins/O'Connor) to approve minutes from the June 14, 2017 Personnel & Finance Committee Meeting.

DISCUSSION/CONSENT ITEMS

03 <u>2016/2017 End of the Year Expenditures</u> Mr. Neel reported that we are in a position to return approximately \$98,000 to the town, in the close of the fiscal year.

04 <u>2017/2018 Monthly Expenditures</u>

Mr. Neel reported that the General Operating Fund is approximately 68.1% encumbered, the Pupil Services is approximately 68.7% encumbered for a consolidated total of 68.2% encumbered, which is where he would expect to be at this time of the year.

05 <u>2016/2017 Special Education Tuition & Transportation End of the Year Expenditures</u>

Mr. Cicarella reported that a combined \$3.4 million was expended on tuition and transportation, creating a budget deficit of \$456,000 prior to the Excess Cost Reimbursement. A reimbursement of \$616,380 is expected, leaving \$159,841 to be returned to the District's general fund.

06 <u>2017/2018 Special Education Tuition & Transportation Monthly Expenditures</u>

Mr. Cicarella reported that we begin the year with a tuition budget of \$2,262,226 and transportation budget of \$744,613 (\$3,006,839). The approximately \$400,000 reduction in budget from last year is due to the professional development and planning that allows us to keep more students with special needs in the district. Superintendent Hernandez and the Board commend Mr. Cicarella for his work. By October, we should have a stronger sense of the stability of our needs, and hopefully, a better sense of what we can expect from the State.
