Superintendent Hernandez stated that the reason for this change is because we do anticipate that the Governor will be extending the school closures beyond April 20. Superintendent Hernandez noted that this is a serious virus and we should be adhering to all of the precautions so that we can get back to a normal environment as quickly as possible. Superintendent Hernandez stated that he would recommend that the Board consider postponing and rescheduling the spring break to dates determined by the administration no later than the end of this week.
