#### 05 B. Communication: Lessons Learned from the Pandemic

Superintendent Hernandez began by saying we have taken time to reflect on the six-week period that was difficult and heard from concerned parents and it was evident in the feedback we received. Our ability to communicate with parents was written and in some people's eyes we fell short. We took a step back and looked at what we could have done better and yes we could have communicated better. We will look into more tools we haven't used in the past for a broader reach. Mr. Hernandez thanked parents for their partnership and stated that in the past a mechanism for us was a parent advisory group that met quarterly. This may be something that we can revisit.

## 06 C. Walsh Intermediate School (WIS) Project Update

Superintendent Hernandez recapped the amount (\$400,000) it would take to get WIS ready to use in the summer. He stated that the project is on schedule and under budget. However, the pool will not be available until January of next year.

Courtney McCarthy, District parent, asked about the immunization data and whether there would be future days off?

Celia Toche, District parent, thanked the Board for holding this meeting and their effort. Ms. Touche thanked Mr. Hernandez for the lessons learned report. Ms. Touche also spoke about effective communication, the use of many channels, surveys the opportunity to talk live, sending emails with letters attached and considering project based learning for summer school.

Gregg Jerolman, Branford resident, spoke about the Board's effort to do the right thing, disingenuousness, lessons learned, Pareto's law, the efforts of some of the Board members, communication issues, the effort of parents, looking at the big picture and strategic issues.

Laura Green, District parent and employee, spoke about public criticism of Superintendent Hernandez, observing a positive interaction with Mr. Hernandez and a fourth grade, his care for students, BOE policy and transparency.

Megan Delucia, District parent, asked about staff vaccination numbers and VAMS, student allergy symptoms and staying home and also COVID testing.

Derek Green, District parent, spoke about communication and meeting video delay. Mr. Green also stated that he was thankful for our kids to be back in school.

Jennifer Orlando, District parent, thanked the Board for having this meeting, for opening it up and changing the forum. Ms. Orlando also discussed her disappointment with the agenda, suggestions from the community, making improvements, the Hornets Nation Facebook page and District policies.
