In his presentation this evening, Jonathan Costa, discussed the following; The Mission (prepare every student for life, learning and work beyond school), The Strategic Process, Branford's Refined Global Competencies (communication and active listening, collaboration, questioning, reasoning and problem solving, adaptability and interest in new learning, demonstrate empathy and kindness and citizenship and civic responsibility), the Definition of Deep Learning, It's About Time: Part I (if you work in an economic system where speed of response is rewarded, AI will be part of your future, or your future is bleak), Vulnerable (ChatGPT can complete the activity with little to now agency from the student) vs. Durable (ChatGPT cannot complete the activity for the student. The student must be fully engaged with the learning task), ranking activities (most to least vulnerable), Good News (the technology that has made certain lessons vulnerable can be used to make them more durable), One Problem (what is the one resource that all durable activities use more than vulnerable activities?), It's About Time: Part II (durable instructional activities take more time than vulnerable instruction activities. What are you NOT going to do so you can do this?), historical approaches to reform, Essential AI Questions (how much of what we currently teach ((and test)) are made irrelevant by these ((and future)) advances), are we strong

enough to prioritize durable over vulnerable and say no, an assortment of AI driven educational enhancements and disruptions, Identified Priority Gaps (equitable outcomes for all student – all means all, alignment of key goals, measures and practices with the Global Learning Competencies ((GLCs)) and Definition of Deep Learning ((DODL)), and communication), the work to be done (Strategy One – ensuring equal opportunity for success for all students, Strategy Two – align the key systems of curriculum, instruction and assessment to support the acquisition of GLCs and DODL, Strategy Three – Improve communication with critical stakeholders) and Board actions moving forward.

03 B. Participate in a discussion of legislative updates to inform policy decisions for the 2023-2024 school year.

In her presentation this evening, Attorney Dori Antonetti, discussed:

- a. Changes Related to Board Operations (new BOE member required training, Board meeting agenda and document posting, publishing school district receipts, expenditures and statistics and April Enrollment Report.
- b. Changes Related to Facilities (school indoor air quality and HVAC inspections and optimal temperature comfort range guidelines).
- c. Changes related to teachers and employees (teacher performance evaluations, CSDE review of school Boards' increasing Educator Diversity Plans, exit survey for teachers leaving the profession and teacher attrition rates, School Nurses and Nurse Practitioners appointment qualifications and professional development, Paraeducators professional development and PDEC membership and changes to paid sick leave for service workers).
- d. Changes related to students (age for special education eligibility, raising the kindergarten starting age, bullying and school climate and restorative practices response policy).
- e. Changes related to teaching and curriculum (required program of instruction, new and revised graduation requirements, play-based learning during preschool, kindergarten and grades one to five, access to curriculum, implementation of reading models or programs and changes related to special education).
- f. Miscellaneous changes of note (expanding opioid antagonist access, opioid antagonist bulk purchase fund, Title IX compliance toolkit for school districts, Statewide Master Test Audit, Suspension and Expulsion Response and Improvement Plans.
