Program Overview

Planning for Summer Programs 2024 is well underway! Alicia Loesche is again serving as Director of Summer Programs. Alicia has extensive experience in this role and is committed to providing students with a rich summer experience.

Our goals for summer programming are shifting this year. We will have a greater emphasis on academic engagement. All students were welcome to enroll and extensive outreach occurred for at risk students. Our goals are as follows:

Continue to academically engage at risk and typical students through the month of July

Reduce the likelihood of "summer slide" in elementary and intermediate school students

Provide credit recovery opportunities to high school students in order to ensure they are on-track to graduate

Provide high school with the opportunity to obtain lifeguard certification or learn American Sign Language

Program Offerings

Students entering grades 1-8 will experience approximately 45 minutes of ELA instruction and activities, 45 minutes of mathematics instruction and activities, 30 minutes of enrichment activities, and a 30 minute lunch. We aim to make our summer instruction as fun and engaging

as possible and will use games, activities, and projects to inspire students. Programs for these students will take place at Walsh Intermediate School.

At the high school level, students will have to recover credits that they may have lost due to lack of mastery of content or poor attendance. This assists high school students with staying on track to graduate. Credit recovery classes take place at Branford High School. Rising 9th through 12th grade students are also invited to participate in lifeguard certification (at WIS) or a course in American Sign Language (at BHS).

Staffing

Branford's very own talented teachers and paraeducators will staff the Summer Programs. We have successfully appointed our director, as previously mentioned, as well as our five coordinators: Megan Paul (BHS), Stephanie Proffena (WIS), Christine Glazewski (elementary), and Kyle Jones and Lauren Osgood (special education). We are currently working to recruit 13 elementary teachers, 12 regular education paraprofessionals, six middle school teachers, one English Language teacher, 13 special education teachers, eight related service providers, and 31 special education paraprofessionals. This team will be overseen by Alicia Loesche, Director of Summer programs.

Funding

The regular education programming will be funded through remaining ARP/ESSER grant money. As these funds are limited, we have a reduced budget. This, in part, prompted some of the more focused programming.

The special education programming is funded through our special education operating budget. Students with IEPs attend Extended School Year (ESY) when the team deems it necessary at a planning and placement team meeting (PPT).




What will we measure?
