1. Approval of minutes:

A. March 5, 2025

Chairperson Sweeney noted the word Branford should be added to section 2B.

**Neil Goodlad made a motion to approve the minutes with the edit by Chairperson Sweeney.**

**Carol Kaminsky seconded the motion which passed.**

**Karyl Lee Hall abstained.**

2. Correspondence and Announcements:

A. Email from Gary @ DPW re: cutting of vegetation at Chet's Pond/Shoreline Greenway Trail (Response sent to Larry Albert via email)

Chairperson Sweeney read the email and the commission discussed it. She said she forwarded it to the resident who inquired.

N. Goodlad disagreed with the email and asked if he could meet with Heather Wells Sweeney to set up a meeting with Gary from DPW to discuss it further.

Chairperson Sweeney said she would set up a meeting.

B. Email from Town Engineer announcing Chestnut Street/Supply Ponds bridge project

Chairperson Sweeney noted she misplaced the email and there was a meeting about this item last night and she will look into what happened at the meeting and report back.

C. Presentation of Budget to Board of Finance; Ways and Means

Chairperson Sweeney said she presented the commissions budget and

there were no comments from anyone. The next meeting is mid-April with the Ways & Means Committee. She will report back on that meeting at the next meeting.

Also, she received a letter from the attorney representing the applicant for a project on 25 South Montowese Street . They had gone before the Zoning Board of appeals and this commission had sent a letter with some concerns. The attorney would like to meet with the commission to discuss their concerns.

The commission then discussed how to proceed. A suggestion was made to contact the Town Attorney for guidance. Karyl Lee Hall offered to work with Chairperson Sweeney in drafting a response letter.

### 3. New Business:

#### A. Report from Karen Hannon on the Living Shorelines Workshop

Karen Hannon attended the workshop and said it was very informative and interesting. Some representatives from DEEP were there and gave some valuable information on how to protect birds, etc. The Audubon Society was also there and gave a great presentation.

#### B. Report from Lauren Ruotolo on the Annual Conference of the Connecticut Land Conservation Council

Lauren attended and noted it was mostly catered to Land Trust and the theme was rewilding, inner city areas, nurture what nature is there, and more. She enjoyed the communication aspect and said mail and flyers are effective ways to get info out. She got some good ideas out of the conference.

### 4. Previous Business:

#### A. Tree Give-away with Community Forest Commission—need volunteers

Chairperson Sweeney noted that the date will be either 4-26-25 or 5-17-25 for the tree give away and help is needed. Please let her know if you can help out.

#### B. Eric Lepeak's proposal

Chairperson Sweeney and Neil Goodlad met with Eric noting that he's interested in planting food items, and he is looking at areas of town that are covered in invasives. His thought was perhaps the soil can be repaired and food items planted there.

Eric was present at the meeting and spoke briefly, noting he would like to connect with more people in the town and what Heather stated was correct.

The commission discussed this a bit, noting this was brought up in the past as a possible idea.

Chairperson Sweeney mentioned she didn't add this item to Previous Business but should have: Rodenticides & Neonics.

She turned this item over to Patrick Sweeney since he was going to reach

out to some people regarding this topic.

P. Sweeney then spoke saying he reached out to four individuals: Gary Zelensky from Public Works, Dale Izzo who is the new head of Parks & Recreation and David who is the chair of the Green Committee.

Also, the head of facilities of the Schools in Branford. They seemed like the relevant people to reach out to because the task was to contact people who might be utilizing neonic herbicides or using the second generation rodenticides.

He heard back from the head of facilities, and he said they are prohibited from using some things on school grounds because there are children there. He learned that the Green Committee is not involved in landscaping. He is waiting to hear back from the other people.

The commission discussed this briefly.
