The meeting was called to order at 8:06am.

- I. Minutes: Minutes from December 8, 2020 meeting were read and approved with correction made. Board member Sarah Lockery presented concerns about staff sharing front office and possible COVID-related issues. It was clarified that staff have opted to continue working in shared space and are aware of risks.
- II. Communications: No communications of significance were received.
- III. Income (donations, fees, etc.): Total income from revenue for the period of 07/01/2020 01/08/2021 was \$342,149, which is approximately 68% of our budgeted revenue of \$500,000 for the fiscal year. Total donations for that same period equaled \$43,246.01 in cash and checks. This amount does not include the approximately \$51,000 in gift cards donated for the Secret Santa Program.
- IV. Statistics: Direct service productivity is at an average of 52%. No show rates remain consistent around 8%, but cancellation rates have decreased from an average of 17% during FY 2019-2020 to an average of closer to 9% for FY 2020-2021. This is thought to be due to the change from in person appointments to telehealth/phone reducing the common cancellation reasons (weather, no transportation, etc.).
- V. Social Services/Basic Needs Account: Basic Needs expenditures remain primarily focused on rental assistance at this time, with an increased need being projected once the moratorium on evictions is lifted.
- VI. Public Relations/Fundraising: The Board suggested sending out an appeal to donors in response to the anticipated increased need for rental assistance during the COVID pandemic.

VII. Director's Report:

- Police Accountability Bill Peter continues to work on a collaboration with the Town on having a Social Worker at Branford PD. They would be Town employees and accompany law enforcement officers responding to appropriate community related issues.
- *Budget* The initial budget package was distributed by the Town. It includes a 2% increase, which is down from last fiscal year's 2.5% increase.
- **VIII.** Old Business: No old business was presented.
- **IX.** New Business: No new business was presented.
