Minutes

June 27, 2022

The Board of Finance held a regular meeting on Monday, June 27, 2022 called to order by Chairman Mooney at 7:30 p.m. at Fire Headquarters, 45 North Main Street, Branford, CT. The meeting was available for remote public viewing via BCTV (Comcast Channel 20) and Facebook Live.

The full Board was seated: Joseph Mooney, Chairman, Victor Cassella, Harry DiAdamo, Pamela DeLise, Charles Shelton and Jeffrey Vailette. Also present were Kathryn LaBanca, Assistant Finance Director and Lisa Arpin, Town Clerk and RTM reps in attendance were Peter Black, Carolyn Sires and Frank Twohill. Recreation Director Alex Palluzzi was also in attendance.

1. The Board unanimously approved the minutes of the May 23, 2022 meeting by motion from Mr. Vailette, seconded by Mr. Shelton.

3. The Board heard a budget transfer request from the Alex Palluzzi Director of Parks & Recreation to reappropriate previous capital balances to capital outlay improvements for Veteran's Park tennis court renovations as follows:

Mr. Vailette made the motion to approve the transfer, seconded by Mr. DiAdamo with the vote being unanimous.

RESOLVED: That the Board of Finance recommends to the RTM the transfer of \$63,636 for FY22 to reappropriate Recreation capital balances.

4. Brian Devlin Wastewater Treatment Plant Supervisor presented a request for a favorable opinion for Amendment #1 to the Materials Management Agreement between the Town of Branford and Synagro Northeast LLC for an additional 3-year term for the period 7/1/2022 through June 30, 2025. The agreement has been reviewed by Town Counsel.

By motion from Mr. Vailette, seconded by Mr. Cassella and unanimous vote, a favorable opinion was granted.

RESOLVED: That the Board of Finance grants a favorable opinion for Amendment #1 to the Synagro Northeast LLC Materials Management Agreement for an additional 3-year term for through June 30, 2025.

5. The Board heard an overview from Heather Wells-Sweeney of the Conservation & Environment Commission regarding the Natural Resource Inventory directed by the State every ten years. The transfer request would bring the total capital appropriation to \$30,000, as \$10,000 was previously approved, as indicated in the attached memo. Ms. LaBanca reported the contingency balance would be \$262,125 if all transfers are approved at this meeting.

RESOLVED: That the Board of Finance recommends to the RTM the transfer of \$20,000 for FY22 for the Conservation & Environment Commission budget.

6. Robert Imperato, Tax Collector presented the Suspense List for the 2016 Grand List Year for Board approval. The attached lists total \$174,784 for motor vehicle and \$184,045 for personal property for a total of \$358,829. Mr. Imperato gave an update on MI reports, looking into acceptance of debit/credit cards over the counter, rate books are completed and percentage of collections reports will follow at a later date. By motion from Mr. Vailette, seconded by Mr. Shelton, the request was approved unanimously.

RESOLVED: That the Board of Finance approves the transfer of certain 2016 Grand List year uncollected taxes to the suspense tax book in the amount of \$358,829.

7. In the Finance Director's absence, Assistant Finance Director Kathryn LaBanca presented a FEMA fund update with review of the attached memo. The transfer request as follows:

Mr. Vailette made the motion to approve the transfer, seconded by Ms. DeLise with the vote being unanimous.


RESOLVED: That the Board of Finance recommends to the RTM the transfer of \$161,746 transfer out to the FEMA Fund.



**AMENDMENT #1 TO
MATERIALS MANAGEMENT AGREEMENT**

THIS AMENDMENT ("Amendment") is made as of June _____, 2022 to the Materials Management Agreement dated as of April 17, 2017, (as amended, modified and supplemented as of the date hereof, the "Agreement") by and between The Town of Branford, CT, (Customer) and Synagro Northeast, LLC (Contractor).

WHEREAS, CUSTOMER and CONTRACTOR have mutually agreed to amend the provisions of the AGREEMENT:

NOW THEREFORE, for and in consideration of the premises, the parties mutually agree that the provisions of the AGREEMENT shall be amended as follows:

1. The term of the AGREEMENT shall be extended for the period from July 1, 2022 through June 30, 2025.
2. Rates effective July 1, 2022, will be as follows:
 - \$344.00 per Dry Ton Liquid Disposal with solids between 2.0% to 7%.
 - \$280.00 per Load Transportation Charge
 - Low solids surcharge of \$166.29 per load for material testing less than 2% solids – Regular Transportation Charge applies.
 - Demurrage: \$85.00 per half hour or any part thereof for loading/unloading in excess of 1 hour.
3. Yearly price increases will resume on July 1, 2023, according to the AGREEMENT formula noted in section titled "CPI Adjustment". The new Base CPI Index for this formula will be July 2022, posted by the Bureau of Labor Statistics, Index

#CUURS11SA0 (formerly CUURA103SA0) as set forth in section CPI Adjustment of the Agreement.

4. Article 1, Definition's "N" – "Non-conforming Sludge" is hereby deleted in its entirety and replaced with the following:

"Non-Conforming Material(s)" shall mean any material which (i) fail to meet the testing requirements in Appendix 1, or (ii) Customer Material(s) which, at the sole discretion of the Contractor, are harmful to the incinerator or the operation thereof, are unlawful to transport, including, but not limited to cake solids that fail to pass a paint filter test, or cause any deleterious environmental effects of any kind, or (iii) are excessively malodorous, or have a Percent Total Sulfur concentration of equal to, or great than 5%, or (iv) are Hazardous Material, or (v) contain a concentration of polychlorinated biphenyls equal to or greater than 50 milligrams per kilogram of total solids (on a dry weight basis) or (vi) contains PFOA/PFAS levels in excess of any federal or state guidelines or regulations. For purposes of this definition, Hazardous Materials means any material containing "hazardous waste", "hazardous substance", "toxic substance" or "extremely hazardous substance" as defined, listed or regulated under any applicable Federal, State or local law applicable to the work to be performed under this Agreement.

5. Article 10, Rejection or Revocation of Acceptance of Materials is hereby deleted in its entirety and replaced by the following:

Rejection or Revocation of Acceptance of Materials.

A. Contractor shall have the right to reject any Non-Conforming Sludge prior to taking possession or revoking its acceptance after taking possession of any Non-Conforming Sludge, provided that Contractor notifies Customer by telephone or in writing of such rejection of Non-Conforming Sludges promptly upon Contractor's discovery thereof. Any such notice of rejection not given initially in writing shall be promptly confirmed in writing to Customer. Contractor shall provide Customer with the documentation used to identify Sludge as Non-Conforming, and Customer shall have the right to re-test the Sludge.

B. Within twenty-four (24) hours after receipt of notice of rejection of Non-Conforming Sludge (or such longer period provided that Customer is acting with due diligence), Customer shall in accordance with applicable laws, arrange for and pay all costs associated with the testing, removal and transport of such Non-Conforming Customer Sludge for appropriate processing and disposal unless Customer and Contractor mutually agree to terms including cost for the handling of such Non-Conforming Customer Sludges on a case-by-case basis. If no such agreement is reached and Customer fails to remove Non-Conforming Sludge within 5 business days of the date Customer is notified by Contractor, then Contractor shall have the right, but not the obligation, to remove, store, handle, transport, store, process and dispose of Non-Conforming Customer Sludge and Customer shall reimburse Contractor for all costs and expenses associated therewith, plus 15% of such costs and expenses.

C. If containers are loaded by Customer or its agents, Contractor has the right to refuse loads that are not within legal weight restrictions, are defective, or are not filled to the levels required by this Agreement.

D. Nothing in this section shall be construed to limit Customer obligation to indemnify Contractor.

6. **Article 19 Force Majeure / Change in Law** is hereby deleted in its entirety and replaced with the following:

Force Majeure/ Change in Law - Neither Party shall be liable to the other Party for breach or for failure or delay in the performance of its obligations hereunder caused by any act or occurrence beyond its reasonable control, including, but not limited to: fires; floods; strikes (except any strikes involving a Party's personnel); a change in Federal, State, or local law or ordinance; orders or judgments of any Federal, State or local court, administrative agency or governmental body; accidents; events which impact overall regional disposal capacity, extreme weather conditions including, for example, hurricanes, tornadoes, unusually high amounts of precipitation, unusual extremes of temperature or wind, or unusually extended periods of adverse weather conditions; acts of war, aggression or terrorism (foreign or domestic); equipment failure (other than due to the inadequate maintenance thereof); and acts of God. It is specifically understood that, without limitation, none of the following acts, events or circumstances shall constitute an act or occurrence beyond a Party's reasonable control: (i) reasonably anticipated weather conditions normal for the region in which the work is performed or (ii) any failure to pay any sums in accordance with the terms of this Agreement. Whenever the provisions of this Section are believed to apply, the Party relying thereon shall give prompt notice to the other Party of the circumstances, the basis for applicability of this Section and the time required to cure such breach or delay. Contractor shall promptly provide notice of the need, if any, for additional compensation or for renegotiation of terms in order to mitigate the effects of such event or to comply with a change in law or regulation or interpretation thereof or imposition of any new or increased fee, levy or charge. Contractor shall be entitled to additional time and compensation if such event delays performance into a season different from that assumed when this Agreement was executed. Contractor and Customer shall use reasonable best efforts to agree on appropriate mitigating actions under the circumstances.

8. In the event that Customer becomes aware of unethical or illegal behavior by any Contractor employee, Customer should report such behavior to Synagro through its third-party hotline at 888-577-9486. Reports may be anonymous. Reports may also be submitted on-line at EthicsPoint - Synagro Technologies.

9. In all other respects, the AGREEMENT shall remain in full force and effect.



Re Transfer for Natural Resource Inventory

As the Board may recall from the March 15 public budget hearing, the Branford Conservation and Environment Commission (BCEC) is directed by the State to produce a Natural Resource Inventory (NRI) every 10 years. The BCEC is in the process of developing the scope of work for the project, after which the BCEC will hire someone to complete the work. The BCEC has refrained from spending the balances in our accounts in order to assist in lessening the burden of the expenses of the NRI. In our discussion with the Finance Director, he suggested that we make a request to your board to have these unspent balances transferred to the existing capital account. Finally, as we anticipate the need for more dollars, the First Selectman and Finance Director asked me to increase the request to \$20,000, which would bring the total capital appropriation to \$30,000, as \$10,000 was approved previously.





Attached please find a one page summary of the revenues and expenditures recorded in the FEMA Fund beginning from FY 2020 to the present. As I noted in the past, the COVID funding sources and eligible uses continued to evolve since the beginning of the pandemic. As a result we had to "shuffle the cards" on multiple occasions to improve our chances of securing funds for the community. In addition to the pandemic related expenses, Branford experienced two major storms which are also reflected on the worksheet.


The summary outlines revenues and expenditures by project and takes one through the last two completed fiscal years along with an estimate of activity for FY 2022. Finally the transfer request of \$161,746 will make the fund whole by restoring the fund's balance to FY 2019 levels and thus providing dollars to offset the costs of future disasters. It is also important to underscore that approximately \$140,000 in general fund expenses were moved to the FEMA Fund in FY 2021 to improve our eligibility chances for COVID relief funding. As the Board is aware, moving those expenses from the general fund to the FEMA Fund in FY 2021 resulted in a net positive for the general fund balance.

I am writing to seek the Board's approval to establish a deposit account with Liberty Bank to implement a new Health Savings Account program for members of the firefighter's union.

Recently we discussed the continued erosion of covered lives in the town's medical self-insurance pool as evidenced by the departures of the health district and James Blackstone Memorial Library. Moreover, during the budget workshops the town expressed its aspiration to vacate the self-insurance platform in favor of the Partnership Plan administered by the state. Historically the fire union also expressed their desire to leave the town's insurance pool by migrating to a fully insured health savings account established by the International Association of Fire Fighters. (IAFF) The IAFF medical plan and its corresponding dental plan will be effective July 1, 2022.

Unlike the plans offered by Anthem which include the banking relationship as part of their product design, the IAFF Plan encourages the employer to establish their own bank account as a vehicle for funding the employer contributions. In recent meetings with agents representing the IAFF Plan we noted that communities (towns and fire districts) had good experience with Liberty Bank. The town currently has deposits with Liberty Bank and, as the board may be aware, Liberty Bank operates a branch at 445 West Main Street.

Therefore, I respectfully request that you approve the following resolution:

Resolved: The Board of Finance authorizes the Finance Director to establish a new bank account with Liberty Bank to fund employer contributions pursuant to the agreement to offer the IAFF Health and Wellness Trust to members and retirees of the fire union.
