Board of Finance Chairman Joseph Mooney called the conclusion of fiscal 2019-2020 budget hearings to order at 7:00 p.m. at Branford Fire Headquarters, 45 North Main Street. The full Board was seated—Harry DiAdamo, Victor Cassella, Robert Imperato, Joseph Mooney, Charles Shelton, Jr., and Jeffrey Vailette.
