**BOARD OF FINANCE
REGULAR MEETING MINUTES April 30, 2018**

The meeting was called to order by Chairman Joseph Mooney at 7:30 p.m. at Fire Headquarters, 45 North Main Street. Board of Finance members present were: Victor Cassella, Robert Imperato, Charles Shelton and Jeffrey Vailette and Lorraine Young. Also in attendance were First Selectman Jamie Cosgrove, Finance Director Jim Finch and Town Clerk Lisa Arpin. RTM reps in attendance were Peter Black, Don Conklin and Dennis Flanigan.

1. To approve the minutes of the previous meetings—Chairman Mooney re-referred this item to the next meeting.
2. Citizens Communications – None.
3. To consider, and if appropriate, approve a request from Solid Waste Management Commission to award the “Recycling of Commingled Containers” bid to Murphy Road Recycling LLC of Enfield, CT at a cost to the Town of \$30.00 per ton for fiscal years 2019, 2020 and 2021 with the option for two additional one year extensions. (Materials are to be delivered to their MRR Automated Material Handling facility in Berlin, CT.)

Dan McGowan, Solid Waste Supervisor gave a presentation followed by Q&A from the Board. Mr. McGowan noted the contract has not been vetted by Town Counsel. Chairman Mooney asked for a motion on the item. The motion was moved by Mr. Cassella, seconded by Mr. Vailette. Vote unanimous.

4. To consider, and if appropriate, approve a request from Solid Waste Management Commission to award the “Recycling of Newspaper and Cardboard” bid to Murphy Road Recycling LLC of Enfield, CT at the revenue rates shown below for fiscal years 2019, 2020 and 2021, with the option for two additional one-year extensions. (Materials are to be delivered to their Seaview Avenue Recycling facility in Bridgeport, CT.)

Dan McGowan, Solid Waste Supervisor gave a presentation on the contract. He noted “PPI is pulp paper index” and OCC is “cardboard.” Q&A followed from the Board. A motion to approve the bid was moved by Mr. Cassella seconded by Mr. Valette. Vote unanimous.

5. To consider, and if appropriate, approve a request from Solid Waste Management Commission to award the “Recycling of Scrap Metal” bid to Chase Waste Material Corp. of New Haven, CT at a revenue equal to the American Metal Market’s New York export market for No. 2 bundles plus \$6.00 with a floor price of \$151.00 per gross ton for fiscal years 2019, 2020 and 2021, with the option for two additional one-year extensions. Dan McGowan, Solid Waste Supervisor gave an overview of the contract. A motion to approve the bid was moved by Mr. Imperato seconded by Mr. Valette. Vote unanimous.
6. Otto Berger from the Department of General Government Buildings presented the following budget transfers and answered questions. Mr. Imperato made the motion to approve seconded by Mr. Shelton. Vote unanimous.

Tax Collector Roberta Gill-Brooks presented the Suspense List for the 2012 Grand List Year proposing to modify suspense of personal property at a 100% level instead of previous years where suspense was limited to companies out of business. Motor vehicle and motor vehicle supplemental will remain at 100%, as in the past. Mr. Cassella made the motion to approve the suspense list (per the attached report) seconded by Mr. Imperato as follows: \$60,260.01 in motor vehicle, \$8,356.31 in supplemental motor vehicle and \$100,009.32 in personal property for a total of \$168,625.64.

Mr. Shelton made the motion to approve all the transfers in item 10, seconded by Mr. Imperato. The vote was unanimous.

11. The Finance Director presented a request to increase the credit card limit from \$5,000 to \$10,000 on a credit card assigned to the purchasing clerk and issued through Bank of America. Mr. Valette made the motion to approve the request, seconded by Ms. Young. Vote unanimous.
12. The Board heard a request from the Finance Director Jim Finch to recommend that the Board of Finance appoint the accounting firm of BlumShapiro to perform the annual audit for the fiscal year ending June 30, 2018, at the proposed fee of \$64,000. Mr. Cassella made the motion to approve the request, seconded by Mr. Imperato. Vote unanimous.
13. Jim Finch Finance Director opened the discussion joined by input from Joe Abbatello and Debi Caron from IT, Kathryn LaBanca from Finance and Don Neel from Board of Education. The team gave an extensive overview of recent developments by Tyler related to the Munis I.T. financial system upgrade (from a self-hosted desktop client system to a web-based system.) We currently have four domains segregated (BOE, fire, police, town) and will need to become one domain to receive the required upgrades for full functionality of the necessary software upgrade from version 10.5 to 11.3 (3 versions). Mr. Mooney expressed his disappointment in Tyler for not supporting our project planning, and asked about additional appropriations. Mr. Finch indicated the BOE will partner in contributing to the costs of the implementation of the

upgrade. In addition to the dollar amount in the FY19 IT budget, there is an additional \$37,000 expenditure plus a one-time set up fee based on number of users of approximately \$15,000 to \$20,000. There was Q&A from the Board and no votes were taken on this matter at this time.

14. Adjournment—Chairman Mooney adjourned the meeting with no further business to be conducted. Motion by Mr. Cassella, seconded by Mr. Shelton. Vote unanimous – meeting adjourned at 8:47 p.m.

As you are aware, the Town of Branford is required by State Statute Section 7-396 to appoint an independent auditor thirty days before the end of the fiscal year.

Sec. 7-396. Designation of auditor The regional board of education and appointing authority of any municipality or audited agency shall file with the Secretary of the Office of Policy and Management the name of the independent auditor, designated to audit the financial statements of the regional school district, municipality, or audited agency, at least thirty days before the end of the fiscal period of such regional school district, municipality, or audited agency for which such audit is required. If any such appointing authority fails to notify the secretary of such designation before such thirty-day period, said secretary may appoint any independent auditor to audit the accounts of such regional school district, municipality or audited agency, and the cost and expense of such audit shall be borne by such regional school district, municipality or audited agency.

In consultation with First Selectmen Cosgrove and Chairman Mooney I recommend that the Board appoint BlumShapiro as auditor for the year ending 6-30-2018. The firm is seeking an increase of \$800 for a total fee of 64,000.


