Apparatus – no report. It was noted that the new ambulance has been ordered and is expected to be finished by the third week of September.

EMS – no report. It was noted that the revenue for FY 2017 was \$1,902,495. So far July revenues are higher than last year's revenues for the same time period.

Buildings – Commissioner Carfora reported that Station 9 schematic design is complete. The cost estimates for the project greatly exceed the budget.

Pension & Communications – no report.

Chief's Report – Chief Mahoney reported that the department continues to remain busy. They had four fires this month. A brief discussion took place concerning the recent tragic drowning of Ben Callahan. The department has purchased an underwater sonar device and is currently looking at purchasing another boat that would be able to access areas that the current water craft cannot get into.

Assistant Chief's Report – Assistant Chief Heffernan reported that he was investigating a case involving DCF. There was a truck fire at Waste Tech. He is working on getting the grant year end reporting completed.
