Chief Mahoney presented the 2020/2021 budget. The operating budget was presented with a 3.82% increase over the current budget. The increase is mainly due to contractual costs and the increase for the cost of the hydrants. Everything else is minimal or flat. Discussion took place concerning the capital budget, items reviewed included the vehicle replacement plan, radio sinking fund, Ambulance replacement plan, Cardiac Monitor plan and SBCA. Discussion took place concerning ambulance revenues and call volume.

Motion made by Commissioner Fox to approve the proposed budget allowing for adjustments /amendments by the Finance Director and/or First Selectman. Seconded by Commissioner LaCroix. Vote unanimous.
