- 2 Call to Order
 - 2.1 Chairman A. Pulcinella called the meeting to order at 5:00 P.M.
- 3 Approval of Minutes
 - 3.1 June minutes were reviewed and discussed. A motion was made by R. Stoecker and seconded by R. Zettergren to accept the June 13, 2017 minutes

4 Public Forum

- 4.1 Criscuolo Engineering was present to discuss drainage pipe relocation for 4-6 Indian Neck Avenue. The commission had approved the CTDEEP Permit Consultation Form in April. A plan for a new hotel on the property called for a redesign of the pipe routing. The project does not change the area drained,or size of pipe diameter (36") The pipes will be watertight with baffled manholes and drainage will be improved on site with oversized sumps and hoods on site. After discussion it was determined that as with the prior CTDEEP form a finding that there would be no adverse impact on the natural beds with movement of pipe was made by M. Hallier and seconded by D. Steinhardt and unanimously approved.
