- 10.1 Ben Goetsch sought any input on his lease application. T. Pulcinella noted that B. Goetsch latest letter was forwarded to First Selectman Cosgrove which is planned to reviewed by the Board of Selectman. T. Pulcinella noted that Town Counsel Attorney Mike Cretella instructed the Shellfish Commission not to act on any leases until matter of jurisdiction/ownership is resolved. It does not appear that the issue will be resolved quickly.
- 10.2 T. Pulcinella updated the Commission on the Dan Snyder legal case. D. Snyder was deposed and stated he didn't know anything about shellfishing. He did acknowledge that he did open a letter addressed to the Shellfish Commission in the mail slot. D. Snyder has a \$17 million claim against the Town. The Town has hired an expert witness from Rhode Island for the case.
