Meeting Minutes November 17, 2022

Upcoming programs for 2023 pertaining to these grants include Exercise for Better Balance, Meditation Relaxation Plus and Kinema Fit for Seniors, which incorporates technology with fitness. Dagmar is still working with the State coalition. As for Social Services, there is no formal report. With the heating season well underway, Medicare Review time and a staff vacancy, it is an extremely busy time. There is a good deal of anxiety, and people desire face to face meetings and conversation.
