Chairperson Hannon said after the commission submitted the letter supporting house bill restricting rodenticides, it then went to the senate. It was combined with the second generation ,anticoagulant rodenticides as well as info about climate. She sent a letter on her personal behalf. She didn't feel the commission had enough time to review the information and be well enough informed to send a letter. She wasn't sure if the commission could comment on just a portion of the bill. She asked for someone to reach out to their legislators to find out. The wording of the bill is very lengthy and complicated. Chairperson Sweeney said she would send an email to the group with email addresses if they wanted to comment as an individual.
