MINUTES OF SPECIAL SELECTMEN'S MEETING

January 3, 2018

Fire Department Headquarters – 6:00 p.m.

The meeting was called to order at 6:00 p.m. Present were First Selectman James B. Cosgrove; Second Selectman Joseph E. Higgins, Jr. and Third Selectman John J. Ahern. Also present were: Thomas Mahoney, Fire Chief; Alex Palluzzi, Director, Parks and Recreation and Ray Ingraham, RTM Member.

Motion made by Selectman Ahern to approve a request from Thomas Mahoney, Fire Chief to waive the bid for the purchase of 10 sets of turn out gear and award the contract to Shipman's Fire Equipment in the amount of \$26,566.50. Seconded by Selectman Higgins. Vote unanimous

Motion made by Selectman Ahern to approve the granting of an easement to Eversource over Town own land at 100 Tabor Drive and 48-86 Tabor Drive to replace existing poles and utility lines and install additional poles and utility lines for electric service to the solar array project on 48-86 Tabor Drive. Cosgrove currently holds the Office of First Selectman and has held that office since November 19, 2013. The First Selectman is further authorized to provide such additional information and execute such other documents as may be required by the local, state or federal government in connection with said contract and to execute any amendments, rescissions and revisions thereto.


