

MINUTES OF SELECTMEN'S MEETING January 18, 2017 – approved by the BOS 02-01-17 Fire Department Headquarters – 6:00 p.m.

The meeting was called to order at 5:59 p.m. Present were First Selectman James B. Cosgrove; Second Selectman Joseph E. Higgins, Jr. and Third Selectman John J. Ahern. Also present were: Patrick Allen, Attorney; Alex Palluzzi, Director, Parks and Recreation; Ray Ingraham, RTM member; and Angie Higgins.

Motion made by Selectman Higgins to approve the Board of Selectmen minutes of January 9, 2017. Seconded by Selectman Ahern. Vote unanimous.

Motion made by Selectman Higgins to enter into executive session at 5:59 to discuss pending litigation. First Selectman Cosgrove invited Attorney Patrick Allen to attend the executive session. Seconded by Selectman Ahern. Vote unanimous.

Present were First Selectman James B. Cosgrove; Second Selectman Joseph E. Higgins, Jr.; Third Selectman John J. Ahern and Attorney Patrick Allen.

Motion made by Selectman Higgins to return to regular session at 6:06 p.m. Seconded by Selectman Ahern. Vote unanimous.

Motion made by Selectman Ahern to approve a settlement agreement as proposed by Attorney Patrick Allen in the Criscio v. Town of Branford lawsuit. Seconded by Selectman Higgins. Vote unanimous.

Motion made by Selectman Higgins to approve a shellfish lease agreement between the Town of Branford and Nicholas Pastore for bed #565. Seconded by Selectman Higgins. Vote unanimous.
