

## MINUTES OF SELECTMEN'S MEETING February 21, 2018 – unapproved Fire Department Headquarters – 6:00 p.m.

The meeting was called to order at 6:00 p.m. Present were First Selectman James B. Cosgrove; Second Selectman Joseph E. Higgins, Jr. and Third Selectman John J. Ahern. Also present were: Attorney James Perito; Alexandra Hernandez, BHS Student; Olivia Kallert, BHS Student; and Angie Higgins.

Motion made by First Selectman Cosgrove to approve the Board of Selectmen minutes of January 24, 2018 (special meeting). Seconded by Selectman Higgins. Selectman Ahern abstained. Vote 2 yeas, 1 abstention.

Motion made by Selectman Ahern to enter into executive session at 6:00 to discuss pending tax appeals. First Selectman Cosgrove invited Attorney James Perito to attend the executive session. Seconded by Selectman Higgins. Vote unanimous.

Present were First Selectman James B. Cosgrove; Second Selectman Joseph E. Higgins, Jr.; Third Selectman John J. Ahern and Attorney James Perito.

Motion made by Selectman Ahern to return to regular session at 6:06 p.m. Seconded by Selectman Higgins. Vote unanimous.

For the record no votes were taken while in executive session.

Motion made by Selectman Higgins to approve a proposed settlement in the Harrison v. Town of Branford – 280 Linden Avenue pending tax appeal. Seconded by Selectman Ahern. Vote unanimous.

Motion made by Selectman Higgins to approve a request from Police Chief Kevin Halloran to waive the requirement for sale to the highest bidder as permitted by Section 73-2 and allow the Police Department to trade in ten (10) H& K USP Compacts .40 cal. pistols for a trade value of \$2,000. Seconded by Selectman Ahern. Vote unanimous.
