

MINUTES OF SELECTMEN'S MEETING May 2, 2018 Fire Headquarters - 6:00 p.m.

Motion made by Selectman Higgins to approve the minutes from April 4 as corrected by the Clerk and April 10, 2018 (special meeting). Seconded by Selectman Ahern. Vote unanimous.
