

MINUTES OF SELECTMEN'S MEETING August 21, 2019 Fire Headquarters - 6:00 p.m.

Motion made by Selectman Ahern to approve the minutes of July 17, 2019. Seconded by Selectman Higgins. Vote unanimous.

Motion made by Selectman Higgins to add under appointments: The appointment of Thomas Mahoney as the Emergency Management Director and Timothy Murray at the Assistant Emergency Management Director.

Motion made by Selectman Ahern to enter into executive session at 6:01 p.m. to discuss pending tax appeals. First Selectman Cosgrove invited Attorney James Perito was invited to attend the executive session. Seconded by Selectman Higgins. Vote unanimous.
