Motion made by Selectwoman Higgins to approve the minutes from November 20, 2024, December 11, 2024 (special meeting) as corrected by the Clerk, December 20, 2024 (special meeting) and January 24, 2025 (special meeting). Seconded by Selectman Dunbar. Vote unanimous.
