Minutes of Selectmen's Meeting June 1, 2022 Fire Headquarters - 5:00 p.m.

The meeting was called to order at 5:00 p.m. Present were First Selectman James B. Cosgrove, Second Selectwoman Angela M. Higgins and Third Selectman Raymond Dunbar. Also present were: Brian Devlin, Superintendent, WWTP; Marie Watson, member, Board of Education; Dan Hally, Marie Watson and RTM members, Frank Twohill, Tracy Everson, Linda Erlanger, Carolyn Sires and Judy Barron.

Motion made by Selectman Dunbar to approve the minutes of May 18, 2022. Seconded by Selectwoman Higgins. Vote unanimous.

Motion made by Selectman Dunbar to approve a request from Brian Devlin, Superintendent, WWTP to waive the bid and approve Amendment #1 to Materials Management Agreement between the Town of Branford and Synagro Northeast LLC for an additional 3 year term for the transportation and incineration of primary/waste activated liquid sludge from the Treatment Plant contingent upon a favorable opinion by the Board of Finance and final review by the Town Attorney. Seconded by Selectwoman Higgins. Vote unanimous.

Motion made by Selectwoman Higgins to approve a request from G Cafe Bakery for the placement of 5 bistro tables and 10 chairs along the sidewalk on Main Street in front of the café. Seconded by Selectman Dunbar. For the record the First Selectman stated that the town will develop a formal application process and have it in place upon the expiration of the current executive order. Vote unanimous.
