Motion made by Selectman Dunbar to approve a four year lease agreement between the Town of Branford and American Capital Financial Services, Inc for 1,000 HP Chromebooks including software and an extended service plan for an annual cost of \$110,520.19 including financing fees. Seconded by Selectwoman Higgins. Vote unanimous.
