Motion made by Selectman Dunbar to approve the minutes of September 20, 2023. Seconded by First Selectman Cosgrove. Vote unanimous.

Motion made by Selectman Dunbar to enter into executive session at 5:02 p.m. to discuss tax appeals First Selectman Cosgrove invited Attorney Perito to attend the executive session. Seconded by First Selectman Cosgrove. Vote unanimous.
