## **Approval of Minutes:**

### Report of the Chief:

Compstat Report – Chief Halloran reported that during the past month the department issued 311 tickets, 70 of which were for cell phone/distracted driver violations. He reported cases of significance including a theft of a wallet outside of a residence, the victim believed that the UPS employee may have been responsible; Breach of Peace arrest following a fight at the post office; Breach of Peace case was reported at Firestone; Attempted Burglary was reported at a commercial business located at 230 East Main Street; Theft of wheels from a 2017 Dodge Ram was reported from Branhaven; Citations were issued for an underage drinking party on 12/31/16; A drug overdose occurred at Cue and Brew; A family violence arrest was made; An accidental shooting took place at Eli's on the Hill in November – the suspect was charged for unlawfully discharging the firearm; A heroin overdose occurred on December23, resulting in death; A fire occurred at 9 Granite Road – A 5 year old had a lit candle on her bed – possible charges pending; A drug arrest occurred of two individuals for possession of marijuana on December 9. YTD Part I Crimes and Quality of Life Crimes generally down.

Forfeiture Report: The Chief reported that the forfeiture balance is \$162,381.39.

Budget Prep starting in January – The Budget committee consists of Commissioners Goodwin, Marcus and Grossman. Chief Halloran reported that there will be a meeting with the First Selectman on Wednesday concerning the upcoming budget.

Request for "No Parking" signs in the vicinity of 638 Main Street. Motion made by Commissioner Hugret to approve the recommendation. Seconded by Commissioner Marcus. Vote unanimous.

Request for signage identifying New England Road as a narrow road only passable by vehicles less than 30' in length. (Flat Rock, Flat Rock Extension and SC Quarry Road.). The Traffic Committee recommended the installation of "Narrow Road No Trucks of 30" sign at the end of Old New England Road. Motion made by Commissioner Hugret to approve the recommendation. Seconded by Commissioner Ryan. Vote unanimous.

A request to revisit a prior request that was denied regarding No Parking on both sides of Little Bay Lane (presently there is No Parking on the west side only). The Traffic Committee recommended no action on this item.

A request for "Tow Zone" signs to be affixed to the existing No Parking Here to Corner signs at the intersections of Bristol and Pentecost from Beckett. The Traffic Committee recommended no action on this item.
