Report of the Chief:

Compstat Report – Chief Halloran reported that during the past month the department issued 422 tickets, 54 of which were for cell phone/distracted driver violations. He reported cases of significance including Theft from Auto at Branfon Honda; Theft of a generator was reported from a residence; Theft from Auto at Al Mac Motors; Tools were reported stolen from the Stony Creek Granite Corporation; Theft of Service occurred at Margarita's; Breach of Peace was

reported at the Elm Café; Untimely Death is being investigated appears to be an overdose of unknown drugs; An arrest warrant is pending in a credit card fraud case involving a Certified Nurse's Assistant.

Forfeiture Report: The Chief reported that the forfeiture balance is \$162,071.99.

Budget:

Chief Halloran reviewed the Budget with the Board.
