Motion made by Selectwoman Higgins to enter into Executive Session at 4:01 p.m. to discuss a proposed settlement in the Gill v. Town of Branford Heart and Hypertension Claim. First Selectman Cosgrove invited Margaret Luberda to attend the executive session. Seconded by Selectman Dunbar. Vote unanimous.

Motion made by Selectman Dunbar to return to regular meeting at 4:06 p.m. Seconded by Selectwoman Higgins. Vote unanimous.

Motion made by Selectwoman Higgins to accept a report from Brian Devlin, Superintendent, Wastewater Treatment Facility for the emergency purchase of two new Homa 29hp pumps for the Bradley Pump Station at a cost of \$43,200. Seconded by Selectman Dunbar. Vote unanimous.

Motion made by Selectman Dunbar to accept a report from Brian Devlin, Superintendent, Wastewater Treatment Facility for emergency work done on at the Squire Hill Pump Station done by Laydon Industries, LLC in the amount of \$20,538.67. Seconded by Selectwoman Higgins. Vote unanimous.
