### Approval of Minutes:

#### Report of the Chief:

Compstat Report - Chief Halloran reported that calls for service are up on the A Squad. Cases of significance included the recovery of a stolen motor vehicle from Wallingford, two individuals were arrested; Theft from auto was reported in the area of Court and Altman streets, two individual were arrested; Criminal Mischief was reported at Joseph Anthony Hair and Nail Salon; Calls for service are up on the B Squad; A sexual assault was reported at Jefferson Road; Shoplifting was reported at the TA Travel Center; Stolen credit card was used on two occasions at Coastal Wine and Liquor, warrant pending; Graffiti was reported at Ecology Park; Vandalism was reported at the Elm Café; Theft was reported at the Holiday Inn, an employee used customer's credit cards for purchases, warrant pending; Shoplifting was reported at Walmart and Stop and Shop; Calls for service are down on the C Squad; Arrest for Possession of a Controlled Substance and Possession of Drug Paraphernalia was made in the Wendy's parking lot; Dui arrest was made after observing eradicate operation on North Main Street; Dispute was reported at Walmart; Assist was made to EHPD for an authorized strip search resulted in locating crack cocaine; Drug overdose reported on East Main Street, the individual was administered Narcan with a positive result.

Motion made by Commissioner Goodwin to appoint Lieutenant Alves to the position of Captain. Seconded by Commissioner Marcus. Vote unanimous.

Training – Chief Halloran reported that Narcan has been deployed into all the patrol cars. He also reported that the Fire Department provided Narcan Training as well as Stop the Bleed Training. He expressed his gratitude to Tom Mahoney, Shaun Heffernan and Gary Bloomquist for providing the training.
