MINUTES OF SPECIAL MEETING: November 19, 2018 at 4:45 p.m.

Approval of Minutes:

Motion made by Commissioner Goodwin to approve the minutes of October 10, 2018. Seconded by Commissioner Sousoulas. Commissioner Hugret abstained.

The Commission had no objections to the 2019 Meeting calendar as presented.

Traffic Committee

- A. Request "Blind Driveway" sign on Alps Road. Motion made by Commissioner Goodwin to approve the request. Seconded by Commissioner Lasala. Vote unanimous.
- B. Request for "Stop" sign on Limewood Avenue. This is a state road - Route 146. The Traffic Committee recommends that the state take a look at this.
- C. Request for an audible on the traffic signal when the walk light is lighted at the corner of Main and Montowese Streets. Motion made by Commissioner Goodwin to consider putting in an audible pedestrian signal at the corner of Main and Montowese Streets. Seconded by Commissioner Hugret. Vote unanimous.
- D. Request for "No Parking" signs on either side of the entrance to the cemetery on Montowese near South Main Street. The Traffic committee recommended putting in crosshatches on either side of the driveway to improve the site line. Commissioner Goodwin stated that since this is state road the recommendation will need to be forwarded to the state. Seconded by Commissioner Hugret. Vote unanimous.


