Branford RTM Administrative Services Committee Minutes for September 6, 2022

A regular meeting of the RTM Administrative Services Committee was held on Tuesday, September 6, 2022, at 7:00 p.m. at the Joseph Trapasso Community Center, 46 Church Street.

1. To consider and, if appropriate, approve the recommendation of the BOF that the RTM evaluate the request to fund the positions of Registrars of Voters on a full-time basis beginning 1/1/2023 for each year of their two-year term of office at a rate of pay recommended by the Human Resources Department and approved by the RTM. This recommendation will be made pursuant to an analysis of the department's operations and staffing requirements.

Rep. Sires made the motion to pass the item with a second by Rep. Twohill. After a lengthy discussion with presentations from Democratic Registrar Dan Halley and Republic Registrar Darren Lawler, Rep. Sires withdrew her motion. Rep. Alfone then made a motion to re-refer the item with a second from Rep. Erlanger. The motion passed 6-1, with Rep. Twohill voting against the motion.
