Aaron Associates will be in next week to begin the SCADA upgrade, from digital to Analog. Upkeep of the grounds at the plant were maintained.

We are waiting for more parts to complete the septic receiving project.

The lab is in the process to replace the air conditioning unit which was 20 years old. It will be on line next week.

The Road Crew continued to camera lines in Town.

The shopping center had a new pump installed

Trucks were serviced.

Sleeving of the pipes by Insituform has been ongoing.
