# Approval of minutes:

# **Sewer Access:**

- a) To consider and if appropriate approve sewer access to 85-101 So Main St, since receiving a positive recommendation by the Town's consultant through a capacity study, subject to a sewer agreement.
  - Kirsten Dooley made a motion to discuss and approve the sewer access for 85-101 So main St, seconded by Mike Tamsin. Motion carried unanimously.
- b) To consider and if appropriate approve increased sewer access to 15 Baldwin Drive, subject to a positive capacity study and revised sewer agreement.
  - Mike Tamsin made a motion to discuss and approve the increase in sewer access of 15 Baldwin Dr, seconded by Kirsten Dooley. Motion carried unanimously.

### To consider and if appropriate approve:

- a) A revised sewer extension plan for 19-25 Fairlawn Avenue
  - Kurt Uihlein made a motion to discuss and approve the connection to the sewer and eliminate the later crossing and to provide a tee and shut off valve and the final design plans to be submitted and approved by the town engineer and the superintendent of the waste water treatment plant, seconded by Mike Tamsin. Motion carried unanimously.

**Receive update on I&I progress:** Received an email with a report updating us on the analysis effort on the collection system. Reports have been written, and the figures have been finalized to show the results of the smoke testing and survey, infiltration and inflow study, 250 N. Main St & South Main St sewer impact study.

# **Wastewater Treatment plant Reports:**

Superintendent Brian Devlin reviewed the Wastewater Treatment numbers: In May 2025, sewage processed 4.1 average mgd, septic waste processed 1,224.471 gallons and septic receiving revenues was \$78,283.26.

# **Plant Operations:**

Serviced all mixers and recycle pumps on aeration basin. Replaced and installed #2 grit pump and new grit screw and bearings in the #2 grit removal chamber. All portable generators were serviced. Rebuilt polymer injection pump and serviced polymer system. Repair UV System.

## Collection system:

Clean, inspect and maintain grounds at all pump stations. Four lateral connections in the center of town have been repaired. Clean pumps at hemlock pump station. Portable flow meters installed at several locations for flow study project. Replaced pump at the cattle crossing Pump Station. Pumped out septic tank at Branford Point. Serviced portable bathroom trailer and delivered trailer to Stoney creek. Jetting footage total 4321 feet Camera footage 3956 feet.

# **Town Attorney Report:**

Town Attorney Peter Berdon said there is nothing new to report besides he is waiting to hear back from Beacon Hill Property, LLC about scheduling a sit down meeting regarding the proposal of sewer extension Rose Hill Rd.
