PISGAH BROOK & SALTONSTALL MTN.:

Hilltop Drive/Green Trail Boardwalk: estimate has been received. Waiting for IWC approval on 12/8/22.

Eppes: P.O. has been issued for boulders reinforcement. Waiting for estimate for boardwalk on White Trail just west of Queach Brook.

Supplemental boulders are needed at Hilltop Drive, Laurel Hill & Blue Trail, behind DeLeo Field at bridge.

BEACON HILL:

Brush was cut along the entire stretch of main trail.

Rehab of parking area and main trail has been completed.

Waiting for kiosk estimate.

P.O. for Welcome sign has been issued.

An estimate for brush cutting along ridge trail has been requested.

QUARRY:

FARM RIVER MEADOW PRESERVE:

The northern boundary has been marked and staked by Land Trust & Parks & Open Space. Major encroachments were identified.
