Minutes for June 12, 2023

A special meeting of the RTM Administrative Services Committee was held on Monday, June 12, 2023, at 7:00 p.m. at the Joseph Trapasso Community Center, 46 Church Street.

The meeting was called to order at 7:02 p.m. with the following members in attendance: Rep. Alfone, Rep. Erlanger, Rep. Everson, Rep. Sires, Rep. Twohill and Rep. Verderame.

1. To consider and if appropriate, approve a transfer request from the Human Services Director for FY2023 as follows:

After a brief discussion, Rep. Alfone made the motion approve to approve the transfer with a second from Rep. Erlanger. The motion passed with 5 in favor and one abstention from Rep. Everson.
