# Representative Town Meeting March 13, 2024 Meeting Minutes

The RTM convened on Wednesday, March 13, 2024, at 8:00 p.m. at Branford Fire Headquarters, 45 North Main Street, to consider and act upon the following matters:

### 1. Call to Order, Pledge of Allegiance

Moderator Amore led the Body in the Pledge of Allegiance.

### 2. Call of the Roll

### 5. To consider, and if appropriate, approve the following Bonding Resolution:

A RESOLUTION AMENDING "RESOLUTION AUTHORIZING AN APPROPRIATION OF \$325,000 FOR THE POLICE HEADQUARTERS RENOVATION PROJECT AND THE FINANCING OF SAID APPROPRIATION BY THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE TOWN AND NOTES IN ANTICIPATION OF SUCH BONDS IN AN AMOUNT NOT TO EXCEED \$325,000 THEREFOR" TO INCREASE THE SCOPE OF THE PROJECT AND INCREASE THE APPROPRIATION AND BOND AUTHORIZATION THEREIN BY AN ADDITIONAL \$20,000,000 BE ADOPTED and recommended for Adoption by the Representative Town Meeting.\*

Rep. Hartwell made a motion to waive the full reading of the bonding resolution. Seconded by Rep. Waterman. Passed the RTM unanimously in a voice vote.

- b) Ways and Means Committee report: Rep. Hartwell stated that this was heard and approved unanimously. He put the matter forward to the full RTM in the form of a motion.

Deputy Police Chief Alves described where Police Services will temporarily relocate to during the renovation.

A roll call vote was unanimous in favor, 27-0.

Rep. Black recused himself from the discussion and vote, Rep. Hartwell stated that Ways and Means heard this item and approved it by unanimous vote. The full RTM voted unanimously in favor, (Rep. Black recused himself.)

11. To consider, and if appropriate, approve an amendment to the Town Code, Chapter 17, Cosgrove Animal Shelter Commission, § 17-2 Membership to remove the reference to the Town of North Branford. (amendment attached)

Rep. Hentschel stated that Rules & Ordinances Committee heard this matter, approved it unanimously and put the matter forward to the full RTM as a motion. Passed unanimously in a roll call vote.

12. To consider, and if appropriate, approve an amendment to the Town Code, to change RTM Rule E. 8.5. Amending, altering or suspending the rules, (2) Suspension of the Rules, to require a supermajority to suspend the Rules. (amendment attached)

Rep. Hentschel reported that Rules & Ordinances Committee heard this matter and put the matter forward as a motion. Supermajority defined as a two-thirds vote. The RTM Rule will now conform to Roberts Rules of Order. Passed unanimously in a roll call vote.

13. To consider, and if appropriate, approve an amendment to the Town Code, to change RTM Rule E. 8.5, Amending, altering or suspending the rules, (1) Alteration or Amendment of the Rules, to require a supermajority to alter or amend the Rules. (amendment attached)

Rep. Hentschel reported that Rules & Ordinances Committee heard this item, passed it unanimously and he put the matter forward in the form of a motion. Supermajority defined as a two-thirds vote. This RTM Rule will now conform to Roberts Rules. Passed unanimously in a roll call vote.

Rep. Twohill moved, Rep. Hartwell seconded, to remove Item 14 from the Call as the same item gets partially repeated in Item 15. Passed unanimously in a voice vote. (Former Item 14 removed from the Call.)

14. To consider, and if appropriate, approve an amendment to the Town Code, RTM Rules, E. Rule 4.5. Committee responsibilities (general) to clarify and coordinate long standing refences to Reports and more recent requirements for Meeting Minutes.

Rep. Hentschel reported that Rules & Ordinances heard this item and unanimously voted to rerefer. Passed unanimously in a voice vote by the full RTM.

Rep. Black moved, Rep. Hentschel seconded, to add an item to the Call #15, Change Date of Annual RTM Budget Meeting. Passed in a unanimous voice vote.

15. To consider, and if appropriate, change the annual RTM Budget Meeting date from May 7 to May 14, 2024.

Rep. Black stated to bring the RTM meeting schedule in conformity with the Town Charter, (Section 5(b),) the annual RTM Budget Meeting date needed to be corrected on the Town Calendar from the first Tuesday in May to the second Tuesday in May, (May 7 to May 14, respectively,) and the new date be recorded in the Town meetings schedule.

Motion to approve by Rep. Black, seconded by Rep. Hynes. Passed 26-1 (Waterman,) in a voice vote.

### 16. Other Business:

- a) Rep. Brooks asked if there was a more concise way to approve long columns of numbers rather than having the Moderator reading all the figures. Moderator Amore referred the matter, if the members want to look at it, to Rules & Ordinances.
- b) Jennifer Ryan expressed her concerns with Parkside Village and the New Haven Housing Authority vouchers that will be used to fund some rentals at Parkside Village for their New Haven Housing Authority tenants. She also mentioned the Parkside Village tax exempt status previously approved by the RTM and questioned Payment in Lieu of taxes, (PILOT,) program availability. First Selectman Cosgrove expressed his concerns as well and is looking into the situation and requesting answers.
- c) Todd Petrowski raised his concerns in the 5th District and asked about Town referendum procedure.
- 17. Call for Adjournment at 9:45 p.m.

Rep. Laich made a motion to adjourn, 2<sup>nd</sup> by Rep. Everson.

WHEREAS, a resolution entitled "RESOLUTION AUTHORIZING AN APPROPRIATION OF \$325,000 FOR THE POLICE HEADQUARTERS RENOVATION PROJECT AND THE FINANCING OF SAID APPROPRIATION BY THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE TOWN AND NOTES IN ANTICIPATION OF SUCH BONDS IN AN AMOUNT NOT TO EXCEED \$325,000 THEREFOR" was adopted by the Representative Town Meeting on February 8, 2023 (the "Original Resolution"); and

WHEREAS, the Town of Branford (the "Town") would like to amend the project scope of the Original Resolution to include the addition of the improvements.

### NOW THEREFORE BE IT RESOLVED:

**Section I.** The Original Resolution is hereby ratified, confirmed and adopted, and is amended to modify the scope of the Project, to increase the appropriation and bond authorization therein by \$20,000,000, from \$325,000 to \$20,325,000, and to make amendments to such resolution as set forth herein.

Section II. The caption of the Original Resolution is replaced in its entirety as follows:

RESOLUTION APPROPRIATING \$20,325,000 FOR THE POLICE HEADQUARTERS RENOVATION PROJECT AND AUTHORIZING THE ISSUE OF \$20,325,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE

Section III. Section 1 of the Original Resolution is replaced in its entirety as follows:

Section 1. The sum of \$20,325,000 is appropriated by the Town of Branford, Connecticut (the "Town"), for (i) preliminary costs (including architectural and construction management fees) to determine the cost and scope of the renovation of the police headquarters located at 33 Laurel Street in the Town (the "Police Headquarters"), (ii) the planning, acquisition and construction of renovations to the Police Headquarters and the firearms training range located at 30 Harrison Avenue in the Town, including, but not limited to, a carport structure, related site improvements, relocation and temporary facility expenses, communications and computer infrastructure and equipment, furniture, fixtures and equipment, utilities, HVAC systems, repair or improvement of structures affected by the construction, testing, remediation,

surveying, and appurtenances related to the foregoing, or so much thereof or such additional improvements as may be accomplished within said appropriation, and for architectural, engineering, other consultant services as required, in part, and approximately in accordance with the Downes Construction Company report dated November 13, 2023, as may be amended, and (iii) insurance, legal, printing, capitalized interest, financing and debt administration costs (the "Project").

**Section IV.** The first sentence of Section 2 of the Original Resolution is replaced in its entirety as follows:

Section 2. To meet said appropriation, \$20,325,000 bonds of the Town or so much thereof as shall be necessary for such purpose, shall be issued, maturing not later than the twentieth year after their date, or such later date as may be allowed by law.

Section V. Sections 3 through 7 of the Original Resolution remain unchanged and are hereby ratified, confirmed and adopted.

I respectfully request the RTM consider establishing a harbor management commission pursuant to CGS 22a-113k. Proper stewardship of Branford's navigable waterways is instrumental in order to maintain the economic, environmental and recreational vitality of these valuable natural resources.

Harbor Master Vincenzo Suppa and I look forward to the opportunity to discuss the merits of a harbor management commission.

Please place this item on the next agenda of the RTM for legislative approval. Thank you for your consideration.

Sec. 22a-113k. Harbor management commissions. (a) Any 2 municipality having within its limits navigable waters as well as the state of the defined in subsection (b) of section 15-3a may establish by ordinance one or more harbor management commissions or may designate any existing board, commission, council, committee or other agency as a harbor management commission. Any harbor management commission established under this section may include one member representing each of the following: The planning commission, the zoning commission, or the combined planning and zoning commission, the conservation commission, shellfish commission and flood control board. The harbor master or deputy harbor master for the municipality shall be a nonvoting exofficio member of any harbor management commission. The ordinance shall designate the area within the territorial limits of the municipality and below the mean high water that shall be within the jurisdiction of a commission and shall set forth the number of members of a commission, their method of selection, terms of office and procedure for filling any vacancy.

- (b) Notwithstanding the provisions of the general statutes or any special act, if an existing municipal waterfront authority, municipal shellfish commission or municipal port authority is designated as a harbor management commission, the municipality may by ordinance increase the membership of such authority, commission or agency and may include one member representing each of the following: The planning commission, the zoning commission, or the combined planning and zoning commission, the conservation commission, shellfish commission and flood control board.
- (c) Any two or more municipalities whose common boundaries lie within navigable waters, as defined in subsection (b) of section 15-3a, may by concurrent ordinances of their legislative bodies establish one or more harbor management commissions. Each such commission shall consist of an equal number of members from each municipality constituted pursuant to subsection (a) of this section. Any municipality that is a member of a commission may, by vote of its legislative body, elect to withdraw from a commission.
