2. Approval of the previous meeting. Motion by Rep. Ingraham to approve the minutes, 2<sup>nd</sup> by Rep. Sullivan. No discussion. Motion approved unanimously.

Rep. Sullivan requested a moment of silence to honor the passing of former Rep. Hansen's father and Superintendent Hernandez's father and their service.

3. The Moderator read the following resolution from Chairman of Board of Finance, Joe Mooney:

To the Representative Town Meeting of The Town of Branford

Attention: Dennis Flanigan, Moderator

At a special meeting of the Board of Finance held December 18, 2017, the following resolution was adopted:

RESOLVED: That the resolution entitled: "RESOLUTION APPROPRIATING \$5,245,000 FOR THE BLACKSTONE MEMORIAL LIBRARY RENOVATION (2018) AND AUTHORIZING THE ISSUE OF \$5,245,000 BONDS OF THE WON TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE" is hereby adopted and recommended for approval by yhe Representative Town Meeting.

The Moderator read a letter from Finance Director Finch that the town will be participating in the Neighborhood Assistance Act Tax Credit Program and referred the item to the Administrative Services Committee.

Rep. Walker requested the body of the RTM to offer thanks to former Rep. Hansen through a round of applause.

#### (EDUCATION COMMITTEE REPORT)

- Motion by Rep. Twohill to approve the recommendation of the Board of Finance of an appropriation of \$57,262,843 to the Board of Education (Operating Budget + Capital) for fiscal year 2018-2019. No discussion. Vote unanimous, item approved.
- Motion by Rep. Twohill to approve Willoughby Wallace Library budget as presented.
- Motion by Rep. Twohill to reduce James Blackstone Memorial Library Budget (JBML) by \$19,703. Amended by Rep. Prete to restore \$9,852 to JBML Budget. 2<sup>nd</sup> by Rep. Sandler. Rep. Jackson provided a minority report.

(ADMINISTRATIVE SERVICES COMMITTEE REPORT)

- Motion by Rep. Alfone to increase IT Budget by \$38,000 (\$37,000 for Munis System Updates, \$1000 for Police Department Software Upgrades) and decrease the Human Services budget by \$37,775 to maintain FY 2017-2018 budget. Rep. Hentschel motions to split motion items into two motions.
  - o IT Budget motion passed with 1 no vote.
  - Human Services Budget: Several Representatives engaged in discussion. Rep. Ingraham requested a recess. Recess granted by the Moderator. Rep. Alfone amended the motion on the floor to reduce \$37,775 from Regular Wages and Salaries. 2<sup>nd</sup> by Rep. Twohill. Motion passes with several no votes.

#### (RULE AND ORDINANCES COMMITTEE REPORT)

• Rep. Leonard motioned to approve Rules and Ordinances budgets as recommended by Board of Finance. Motion passes unanimously.

#### (PUBIC SERVICES COMMITTEE REPORT)

• Rep. Conklin motions to approve Public Services Committee budgets as recommended by Board of Finance. Amended by Rep. Riccio to reduce the Police Overtime budget by \$20,000. 2nd by Rep. Brockett. Amendment carries unanimously. Motion as amended carries unanimously

#### (WAYS AND MEANS COMMITTEE REPORT)

• Rep. Black motions to reduce contingency budget by \$76,955. Motion passes unanimously.

#### RECESS

The Moderator summarized the proposed changes to the budget from the committee reports.

Rep. Jackson makes an amendment to reinstate the JBML budget by \$9,852 to restore the full requested amount. 2<sup>nd</sup> by Rep. Adelman. The amendment is defeated by role call vote YES (11), NO (15). (See Attached)

Rep. Comey made an amendment to restore \$20,000 to the Regular Salaries and Wages line item of the Human Services Budget. 2<sup>nd</sup> by Rep. Hentschel. Amendment defeated.

Rep. Sullivan made an amendment to restore \$18,625 to the IT budget to purchase new computer hardware for the Police Department. 2<sup>nd</sup> by Rep. Hentschel. Amendment defeated.

Rep. Brockett made an amendment to restore the \$66,922 cut by the Board of Finance to fund Police Captain position. 2<sup>nd</sup> by Rep. Sullivan. Amendment defeated

Rep. Sullivan made an amendment to eliminate the Salary and Wages of the Public Works Director (\$100,066), reduce the Human Resources Director Salary by \$42,025, and reduce the Assistant Human Resources Director salary by \$60,193 for

a total reduction of \$202,884. 2<sup>nd</sup> by Rep. Hentschel. Role call vote defeated YES (12) NO (14). (See Attachment)

- 5. To consider and, if appropriate, approve the recommendation of the Board of Finance of an appropriation of \$57,262,843 to the Board of Education (Operating Budget + Capital) for fiscal year 2018-2019.

  Item is approved through role call vote. YES (24). NO(1). (See attached.)
- 6. To consider and, if appropriate, approve the recommendation of the Board of Finance of an appropriation of \$54,924,109 for all other Town Departments (Operating Budget + Capital) for fiscal year 2018-2019. Item is approved as amended with an adjusted amount of \$54,817,528. Item is approved through a role call vote: YES (21) NO (5). (See Attached)
- 7. To consider and, if appropriate, approve the recommendation of the Board of Finance of appropriation of \$59,283 to the Open Space Fund Budget for fiscal year 2018-2019. Rep. Black motion to approve as presented by Board of Finance. Motion approved with NO(1) vote.
- 8. Rep. Black motioned to approve the recommendation of the Board of Finance of an appropriation of \$167,904 to the Sewer Assessment Fund Budget for fiscal 2018-2019. Motion approved unanimously
- 9. Rep. Twohill motioned to approve the recommendation of the Board of Finance of an appropriation of \$60,000 to the Board of Education Special Fund Budget for fiscal year 2018-2019. Motion approved unanimously.
- 10. Rep. Twohill motions to approve the recommendation of the Board of Finance of an appropriation of \$665,250 to the Board of Education Daycare Fund Budget for fiscal 2018-2019. Motion approved unanimously.
- 11. Rep. Leonard motioned to approve the recommendation of the Board of Finance of appropriation of \$4,384,295 to the Wastewater Treatment Plant Budget for fiscal year 2018-2019. Motion Approved unanimously.

- 16. Rep. Leonard motions to re-refer this item: To consider and if appropriate, create Ordinance that enables Tax exemptions for Gold Star Parents and Spouses. Motion approved. The item was re-referred.
- 17. Rep. Leonard motions to re-refer this item: To consider, and if appropriate, create Ordinance for Tax exemption for Handicap equipped vehicles. Motion approved. The item was re-referred.
