- 2. **Approval of the previous meeting.** Rep. Ingraham made a motion to approve the minutes from the October 10, 2018 minutes. 2nd Rep. Dunbar. Approved unanimously.
- 3. Reception of communications, reports of committees, and citizen petitions.

The Moderator read a resolution from Joe Mooney, Chairperson of the Board of Finance alerting the RTM that: At a regular meeting of the Board of Finance held November 26, 2018, the following resolution was adopted:

RESOLVED: That the resolution entitled: "RESOLUTION AMENDING A RESOLUTION APPROPRIATING \$2,100,000 FOR HARBOR STREET CULVERT IMPROVEMENTS AND AUTHORIZING THE ISSUE OF \$2,100,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE

THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE" is hereby adopted and recommended for adoption by the Representative Town Meeting.

The Moderator read correspondence from Rep, Walker proposing that the RTM look into the possibility of banning the purchase, sale, and distribution of plastic helium balloons. The Moderator sent this to the Rules and Ordinances committee for review.

The Moderator read a proposal from Rep. Brockett regarding the policy of flag displays across town property. The Moderator indicated that Rep. Flanigan, Rep. Ingraham, and Rep. Brockett would collaborate to create a proposed resolution for the next RTM meeting.

The Moderator read a request from elector Margaret (Meg) Kilgore to have the RTM review a proposed ban on single use plastic bags in Branford. The proposal was sent to the Rules and Ordinances committee for review and action. Kilgore addressed the RTM to elaborate on the request.

- 4. Rep. Leonard made a motion to re-refer an item to create tax exemptions for handicap vehicles. Motion to re-refer approved unanimously.
- 5. Rep. Leonard made a motion to re-refer the item regarding the review and revise (if appropriate) the limits of the Branford Town Dock Ordinance. Motion to re-refer the item approved unanimously.
- 6. Rep. Leonard made a motion to re-refer the item to consider, review, and propose changes to the Town of Branford Noise Ordinance. Motion to re-refer approved.
- 7. Rep. Flanigan read the 2019 RTM Meeting schedule. (attached). The original schedule was amended to move the meeting on September 11 to September 10. Rep. Ingraham made a motion to approve the schedule as amended, 2nd by Rep. Hentschel. Approved unanimously. Later in the meeting Rep. Twohill made a motion to to amend the calendar to change the November meeting to be held on November 19, per the town code. 2nd by Rep. Riccio. Approved unanimously. See attached for full calendar.

RESOLUTION AMENDING RESOLUTION AMFORD, COM A APPROPRIATING \$2,100,000 FOR HARBOR **STREET** CULVERT IMPROVEMENTS AND AUTHORIZING THE ISSUE OF \$2,100,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION **PENDING** AND THE **ISSUANCE** THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE

Section 1. The Resolution adopted April 12, 2017, entitled "RESOLUTION APPROPRIATING \$2,100,000 FOR HARBOR STREET CULVERT IMPROVEMENTS AND AUTHORIZING THE ISSUE OF \$2,100,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE", which is hereby ratified, confirmed and adopted, is amended by increasing the appropriation and bond authorization by \$100,000 to a total of \$2,200,000 as follows:

Section 2. The title of the Resolution is amended to read as follows:

RESOLUTION APPROPRIATING \$2,200,000 FOR HARBOR STREET CULVERT IMPROVEMENTS AND AUTHORIZING THE ISSUE OF \$2,200,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE

Section 3. Section 2 of the Resolution is amended by substituting the following:

The total estimated cost of the project is \$2,200,000; \$1,021,000 of project costs is estimated to be paid from grants and \$1,179,000,000 from the proposed bond issue.

Section 4. The first sentence of section 3 of the Resolution is amended to read as follows:

"To meet said appropriation, \$2,200,000 bonds of the Town or so much thereof as shall be necessary for such purpose, shall be issued, maturing not later than the twentieth year after their date."

Section 5. The Resolution is further amended by substituting the amount of \$2,200,000 for \$2,100,000, wherever it appears in the Resolution.

Dear Mr. Moderator (Dennis),

I would like to propose that we look into the possibility of banning the purchase, sale, and distribution of plastic helium balloons in the town of Branford. While my wife and I were out of state during the summer months, we did witness hundreds of plastic balloons September-November sailing by and either entangling themselves in trees or landing in Long Island Sound where they pose a significant risk to seabirds and marine life, particularly turtles and fish. These are agents of death along the shoreline, not simply horrific litter. It is my understanding that some forward-thinking locales like Nantucket, parts of Block Island, and Newport have banned these balloons and, quite clearly, with a coagulated sheet of plastic in the Pacific Ocean larger than the country of France, limitations upon the use and distribution of plastic will and should be growing in intensity.

Thank you, Dennis. I hope you and your family have a most enjoyable and healthy holiday season.

Re: Proposed Plastic Bag Ordinance

Dear Moderator,

I am writing to you on behalf of BYO Branford, a group of Branford concerned citizens, who are proposing that an ordinance be adopted by the Branford Representative Town Meeting (RTM), with the purpose to protect and improve the environment of Branford including its coastline and marine life, and the health, safety, and welfare of its residents by reducing the use of plastic and paper bags and encouraging the use of reusable checkout bags when making retail purchases.

Our BYO Branford group has collected over 830 signatures of Branford residents over 18 years old! We also have shown an informative, interesting movie called "Bag It" on four occasions and will continue to show it to various groups within our town.

We have talked to Branford merchants on Main St., West Main St., North Main St., Leetes Island Rd., and Brushy Hill Plaza. Twenty merchants have publically supported our effort, and an additional 13 agreed to put up our poster reminding shoppers to use their own reusable bags for checkout!

In addition, we have designed a large cloth washable shopping bag with our logo on one side and that of Connecticut Fund for the Environment/Save the Sound on the other side. To date we have given out 300 of these bags to residents excited about using them when shopping. And, we will continue to order more to distribute. Plus, coming up soon, our committee will be collecting extra cloth shopping bags from residents and our committee members to distribute to additional residents without cloth shopping bags.

Here are a few statistics that have encouraged our group members to dedicate themselves to this effort:

Single-use plastic bags:

- Usually get tossed after a single use and 20% of them wind up in the ocean
- Break down into tiny pieces that enter the food chain and are toxic to humans and animals
- Trap and are eaten by whales, birds, and turtles and kill wildlife

Get loose as litter and are a blight on the landscape

- Accumulate in 5 different trash islands that cover up to 8% of the oceans
- WE HAVE ALTERNATIVES. SIMPLE SOLUTIONS LIKE REUSABLE SHOPPING BAGS!!

Branford has 20 miles of coastline, and is known for its Thimble Islands, Branford Harbor and River, boating, fishing, clams and oyster beds, and swimming, plus spectacular views along the shore. All of this is one of Branford's most valuable assets. We ask for support from the RTM to pass this ordinance to help protect it now!
