xxx-1. Rules and regulations.

The Board of Selectmen is authorized to adopt by majority vote such rules and regulations as it shall determine from time to time regarding the restrictions on the public and commercial use of Town-owned parking lots. Such rules may be made applicable to all Town-owned parking lots or may be specific to specified lots.

§ xxx-2. Posting of Regulations.

Notice of such regulations shall be posted in applicable lots as a requirement of enforcement.

§ xxx-3. Violations and penalties.

Any person who shall violate any rule or regulation established by the Board of Selectmen under the provisions of this article shall be fined no more than \$100 for each offense.

§ xxx-4. Enforcement.

The following officers and agents of the Town of Branford are authorized to act as Enforcement Officers for the provisions of this ordinance.

(a) All officers of the Branford Police Department (per State of CT Statute)

(b) Any agent of the Town duly appointed by the Board of Selectmen to enforce this ordinance.

(d) Any Town of Branford Community Service Officer

§ xxx-5 - Enforcement Procedures

(a) For Officers of the Branford Police Department, the enforcement procedures stipulated by State of CT Statute shall apply.

(b) For any Town of Branford designated Enforcement Officer, the procedures for the issuance of warnings,

Issuance of citations and any requested hearings for violations of this ordinance shall follow the requirements of the Branford Town Code.

- 3. To consider and make a recommendation to the full RTM regarding disestablishment of the water commission. Sec 105-1 et seq.
- 4. To consider and make a recommendation to the full RTM regarding repeal of ordinances regarding piggeries. Sec . 118-4 This ordinance is duplicative of zoning regulations regulating large animals, Zoning Regulation 37A (2).
- 5. To review and consider, recommending appropriate action, if any, to the full RTM regarding revision to Code of Ethics.
- 6. To consider, and if appropriate approve amendment to Chapter A236-4 (c) Rule 4.3 section (4) regarding clerks for RTM committees.:

It shall be the duty and responsibility of each standing or special committee to choose a clerk who shall be responsible for taking the minutes of said committee meeting. The committee clerk shall prepare the minutes of each meeting and shall deliver said minutes to the Town Clerk not later than two weeks after said meeting, or prior to the expected action by the full RTM. The minutes shall be posted on the Town's website

7. Other business may be added to the agenda by 2/3 vote of the committee. It is expected that discussion of a proposed Blight ordinance will be held at a future Special Meeting.
