- o Elizabeth Wieland made a motion to approve the minutes.

- Formal Review: 4 Three Elm Road— The applicant/owner David D'Atri is proposing minor alteration to a previously approved Special Exception and Coastal Area Management application for a multi-family residence. Proposed changes include minor architectural modifications to the South, North and West Elevations. In addition the applicant is proposing a change to the roofing and siding material to instead be cement roof tile and North American White Cedar respectively.
 - o The applicant's architect, Edwin de Cossy briefly explained the proposed material changes and scale if the building. He explained that the original roof had been proposed as a standing seam metal roof and is now proposed to be a cement tile roof, designed to resemble slate. The originally proposed wood shingle siding is now proposed as North American White Cedar shiplap siding.
 - Kaitlin Piazza, Assistant Town Planner then briefly reviewed some of the minor architectural changes proposed including extension and alterations of deck areas and reorientation of stairs.
 - Harry Smith, Town planner explained that the agenda would be revised to reflect that the application was for a formal review not informal. He also explained the previous approvals.
 - There was then a brief discussion concerning the materials, windows, trim details and finishes.
 - o The Board briefly discussed and praised the design.

- John Herzan made a motion for a positive recommendation for the proposed design with the condition that the applicant provide the roof samples to the Board when they become available
- o Elizabeth Wieland seconded the motion which passed unanimously.
