- 1. Chairman Muniz called the meeting to order at 6:04 pm
- 2. Chairman Muniz introduced new Commissioner Trudy Muhlbauer and welcomed her to the SWMC
- **3.** K Galambos moved to approve the minutes of the meeting of Sept 2023, R Aitro seconded, and the motion passed unanimously (T Muhlbauer abstained)

4. Program Operations:

- a. Recycling Material Costs and Metrics
 - i. T Bowne submitted a written report to the SWMC Commission via email earlier today
 - ii. He reported that the recent decline in Municipal Solid Waste is a good sign, and he will continue to monitor
 - iii. The recycling ACR has returned to base price, which indicates low contamination. Since July there have been only one or two loads deemed contaminated
 - iv. Yard waste collection is going well. The yard waste pickup call-in system is functioning well. 70 people called for pickups on the second day of service. One person who had not called in complained, and ACA made the pickup. Leaf collection is included in the program.
 - v. T Bowne reached out to the new superintendent of schools to discuss recycling of holiday materials at the schools this year.
- b. Curbside Collection Performance Update see T Bowne's report
- c. Transfer Station Performance and Practices Update
 - i. A new "express lane" for recycling and trash has been established at the Transfer Station for residents' convenience.
 - ii. TB is working with the Building Department on possible renovations at the Transfer Station

6. New Business

- a. Contract Status: The SWMC needs to negotiate the contract for rubbish collection of comingled trash & recycling materials accumulated in decorative barrels on the Town Green and in and Stony Creek. Prior contracts required daily and weekend pickups but they were not regularly performed. T Bowne wrote a new contract bid document, Chairman Muniz approved it, and it was sent out last week. The SWMC will hold a Special Meeting to review the bid proposals next week, prior to the Board of Selectman meeting, so that the contract can begin by December 1. The contract will be financed with funds from Material Handling.
- **7.** K Galambos moved to adjourn the meeting, seconded by R Aitro, the motion passed unanimously. Chairman Muniz adjourned the meeting at 6:54 pm


