Prospective bidders, and all those concerned, are hereby informed that the following is made a part of the bid documents, which should be amended as follows:

Questions and Answers

Question 1:

Can a bidder bid on just Leaf Collection or just Yard Waste Collection separately?

Answer:

The Town requests that bidders bid on both items to keep both services under one contract for ease of accounting. The Town will however consider bids if the bidder only bids on one item, rather than both items, but will review bids with a preference for those that bid on both Yard Waste Collection and Leaf Collection.

Question 2:

How will the decision be determined if the Town will implement the optional Yard Waste Collection portion?

Answer:

The Town will take economic and environmental responsibility factors into consideration for reviewing this portion of the bid. The goal is to be able to provide the service in the most environmentally friendly way while also keeping the cost of service economically sufficient. The Town has sole discretion on the implementation of this portion of the Bid and will determine what is in the best interest of the Town.

Question 3:

Can a bidder put a separate section on the bid for fuel adjustment?

Answer:

For ease of accounting, the Town will not be providing a direct fuel adjustment for this contract. The bidder should factor in all aspects of the service when providing a bid for this contract.

Question 4:

Can the Town provide information on what the collection of leaves has historically costed the Town?

Answer:

It is important to note that the process of leaf collection has historically been lumped into a larger contract for curbside collection of trash and recycling. The price listed below factors in a collection period for leaves that is two weeks longer than the schedule of collection being bid on for this new contract and utilized a collection system that let residents utilize barrels instead of strictly paper leaf bags. Yard waste collection has historically been collected with curbside collection of Municipal Solid Waste (MSW) and therefore the historical pricing does not reflect this service separately.
