Attachment A (Updated Section 2 - Proposal) shall be submitted with bid submission.

1. Specifications and plans do not provide any meaningful specifications on the Gasboy Islander Prime system you wish to have the contractor supply?

Gasboy Island Prime with EKOS software shall be provided.

2. What modules do you require with this system? Fuel card module, bulk fuel module, fleet maintenance module?

Fuel Site Module shall be provided in base bid. Alternate pricing shall be provided for one year of bulk fuel module and one year of fleet maintenance module (see Attachment A).

3. Is system being configured for Proprietary cards, Mag Cards, Fobs or passive fuel ring use? If so, how many proprietary, fobs, mag cards or passive fuel rings to be provided?

Fobs shall be used for this system. 300 Fobs shall be provided. A fob programmer shall also be included in the base bid.

4. If you choose passive fuel rings, do you wish to have them installed? Or do you wish to install them yourself?

Passive fuel rings shall not be installed.

5. Single or dual devise authorization?

Single device authorization shall be used and programmed to specific fleet vehicles for odometer reading.

6. Do we include a receipt printer?

No.

7. Who is supplying dedicated computer hardware to access system?

The Town's IT Department shall provide a fuel management computer with network access.

8. Will town have IT staff available to create and maintain IP address for this system?

Yes, IT Staff will create and maintain an IP address for this system.

9. Do we include site controller software?

EKOS Cloud Based software shall be provided (not FHO software). Hardware is provided in form of the Gasboy Islander Prime Pedestal.

10. Do we include cloud Hosted software?

EKOS Cloud Based software shall be provided with fuel site module.

- 11. Do we include how many years of Cloud Hosted Software access?
 - 1 year of EKOS Cloud based software shall be included in the base bid. Alternate pricing shall be provided for Bulk Fuel and Fleet Maintenance Modules.
- 12. How many years warranty do you wish on this unit? Min is 1 year with optional 5 year warranty.

 5 year warranty shall be provided.
- 13. Access to 24 hour help desk? And for how many years?
 - 1 year help desk shall be provided. Contractor shall also provide owner with training of system upon completion.
